After review and discussion, Mr. Landers moved to approve the following resolution, with the following changes to the policy: Section 11.1 the word "education" in the first sentence change to "educational", Section 16.6 the word "Unethical" was deleted from heading:

Resolved, That the West Virginia University at Parkersburg Board of Governors authorizes a notice of proposed rulemaking for adoption of Policy A-44, *Policy and Procedures Regarding Harassment and Discrimination*, to supersede the June 5, 2014 version of Policy A-44, *Sexual Misconduct and Other Forms of Discrimination and Harassment*, as well as the August 14, 2020 Emergency Policy A-44; and hereby authorizes adoption of said policy without further action by the Board if no comments are received and/or no further edits are recommended within the same period.

Mr. Matheny seconded the motion. Motion passed.
